DECISION ON EIM GOVERNANCE REVIEW PART 2 DRAFT FINAL PROPOSAL

Roger Collanton, Vice President, General Counsel and Chief Compliance Officer, acknowledged receipt of a joint public comment letter (American Clean Power

Association, California Municipal Utilities Association, Environmental Defense Fund, Environmental Entrepreneurs, Independent Energy Producers, Natural Resources Defense Council, UCLA Institute of the Environment & Sustainability, UCLA School of Law, and Stanford University) that was provided to the EIM Governing Body and the Board of Governors.

Next, Therese Hampton, Chair of the EIM Governance Review Committee, provided an overview of the part two draft final proposal, which included recommendations pertaining to joint authority and dispute resolution. She noted the proposal would expand the scope and type of issues over which the EIM Governing Body had formal approval authority. Next, Chair Hampton explained the joint authority process and highlighted that the EIM Governing Body would continue to provide advisory input to the Board of Governors on relevant initiatives. Next, she outlined the elements of the dispute resolution process should the Board of Governors and the EIM Governing Body not reach a joint decision. Chair Hampton concluded by noting stakeholders generally supported the EIM Governance Review Committee's part two draft final proposal, and highlighted the public comments received during the August 2 EIM Governance Review Committee's general session meeting.
