PUBLIC COMMENT

There was no public comment.

DECISION ON EIM GOVERNANCE REVIEW COMMITTEE MEMBERSHIP

Stacey Crowley, Vice President – External Affairs, provided a brief update on the EIM Governance Review Committee membership and the three open seats vacated by Jennifer Gardner, Doug Howe and Mary Wiencke. Next, Ms. Crowley explained the process the ISO underwent to solicit potential candidates. She reported that for the EIM entity sector

seat, Pam Sporborg was identified as the consensus nominee, while Michele Beck was identified as the consensus nominee to represent the interests of consumer advocates. Ms. Crowley added that, following a joint Board of Governors and EIM Governing Body executive session, Amanda Ormond was discussed as the consensus candidate for the remaining vacant seat. DECISION ON TRANSMISSION SERVICES AND MARKET SCHEDULING PRIORITIES – PHASE 1

Greg Cook, Executive Director – Market Policy & Performance, presented Management's proposal on the transmission service and market scheduling priorities – phase 1 initiative. Mr. Cook explained that Management's proposal addressed current rules for wheel-through transactions that were due to expire in June 2022. He added that phase 1 fell within the EIM Governing Body's advisory role. Next, Mr. Cook informed the EIM Governing Body and the Board of Governors that Management's proposal would modify rules that govern whether, and to what extent, schedules for wheel-through transactions from the ISO balancing authority area would receive priority through June 1, 2024. Next, Mr. Cook summarized the benefits of the proposal and how changes to variable energy resources could support high priority exports. To conclude, Mr. Cook reported that stakeholders largely supported the proposal. He added there was a fair amount of support for the extension of the current market scheduling priorities. Discussion followed and Management provided responsive comments.

Moved, that the ISO Board of Governors authorizes Management to make all necessary and appropriate filings with the Federal Energy Regulatory Commission to implement the proposal described in the memorandum, including any filings that implement the overarching initiative policy but contain discrete revisions to incorporate Commission guidance in any initial ruling on the proposed tariff amendment.

The motion was seconded by Governor Schori and approved 5-0.
