Dear Secretary Bose:

The California Independent System Operator Corporation ("CAISO") hereby submits for filing a Certificate of Concurrence with respect to the Small Generator Interconnection Agreement ("SGIA") among Solar Star California XLIV, LLC and California Department of Water Resources ("Interconnection Customer"), Southern California Edison Company ("SCE"), and the CAISO ("Pearblossom SGIA").¹

I. Overview and Designated Filer

On December 1, 2015, SCE submitted the Pearblossom SGIA in Docket No. ER16-443-000, with a requested effective date of December 2, 2015. In that filing, SCE explained that the Interconnection Customer submitted a request to the CAISO pursuant to the CAISO Tariff Generator Interconnection and Deliverability Allocation Procedures to interconnect a proposed 9.5 net MW (10 gross MW) solar photovoltaic generating facility named the Pearblossom Solar Project ("Project"), to be located in Pearblossom, California, and transmit energy to the CAISO controlled grid. Interconnection Customer proposes to interconnect to SCE's Vincent Substation at the 220 kV bus by utilizing the existing Pearblossom-Vincent 220kV transmission line. Currently, the Pearblossom-Vincent 220kV transmission line is solely used to interconnect CDWR's existing Pearblossom Pumping Plant.1 SCE owns approximately 13.1 miles of the Pearblossom-Vincent 220kV transmission line outside of CDWR's property line, and CDWR owns the portion of the line that is located on its property. The Interconnection Customer proposes to interconnect the Project to the portion of the line

owned by CDWR. The Interconnection Customer proposes a commercial operation date of December 16, 2016 for the Project. Because of the Interconnection Customer's unique nature as a state entity, the Pearblossom SGIA deviates from the CAISO *pro forma* SGIA, as explained in SCE's December 1, 2015 filing.

Rather than filing a duplicate version of the Pearblossom SGIA under the CAISO tariff, the CAISO is submitting a concurrence tariff record. The concurrence tariff record is designated under the CASO tariff as Service Agreement No. 3480.

SCE serves as the "designated filer" as to the Pearblossom SGIA pursuant to the Joint Tariff Filing procedures outlined in Order No. 714.² As the Participating Transmission Owner and a party to the SGIA, SCE filed the service agreement under SCE's FERC Electric Tariff, Original Volume No. 6 and designated it as Service Agreement No. 177.

II. Proposed Effective Date and General Request for Waivers

The CAISO respectfully requests any waivers of the Commission's filing regulations necessary to establish an effective date of December 2, 2015 for its Certificate of Concurrence for the Pearblossom SGIA, consistent with the December 2, 2015 effective date that SCE requested in its December 1, 2015 filing. To the extent that the enclosed materials and information do not meet the detailed filing requirements of the Commission's regulations, the CAISO respectfully requests that the Commission grant any necessary waivers.
