On December 16, 2008, the California Independent System Operator Corporation (CAISO) submitted an informational filing that provides notice regarding the CAISO's revised Transmission Access Charges for four consecutive periods beginning March 1, 2008 and ending August 31, 2008. The CAISO states that the basis for the revision is to implement the revised Transmission Revenue Requirement (TRR) of Pacific Gas and Electric Company (PG&E) as of March 1, 2008 resulting from an uncontested offer of settlement regarding PG&E's proposed TRR revision in its TO10 filing. The revised TRR for PG&E was approved by the Commission in an order issued on October 22, 2008 in Docket Nos. ER07-1213-000, *et al.*¹ Receipt of the CAISO's instant informational filing is acknowledged.

This filing was noticed on December 19, 2008, with comments, protests, or motions to intervene due on or before January 6, 2009. No protests or comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.
