**JOINT RESPONSE OF GEYSERS POWER COMPANY, LLC AND
THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION**


This pleading responds to the June 1, 2005 letter from Ellen Schall, Assistant General Counsel for Markets, Tariffs and Rates to Geysers Power Company, LLC (“Geysers Power”) and the California Independent System Operator Corporation (“CAISO”) regarding the Interim Refund Report and Final Refund Report (the “Refund Reports”) submitted by Geysers Power on March 16, 2000 and September 15, 2000 respectively.¹ Specifically, the letter requests that Geysers Power and the CAISO clarify (1) whether there are any outstanding issues in regard to the Refund Reports; and (2) whether any further action by the Federal Energy Regulatory Commission (“Commission”) is required with respect to the Refund Reports.

¹ The CAISO filed a protest and motion to intervene with respect to the Final Refund Report.

Geysers Power and the CAISO have discussed this matter and believe there are no outstanding issues regarding the Refund Reports and that no further action by the Commission is required in this matter.²


