On May 26, 2023, as amended and supplemented on June 27, 2023, California Independent System Operator Corporation (CAISO) filed revisions to its Open Access Transmission Tariff (OATT) to change the collation values of its tariff records in Appendices L through II. The revisions are accepted for filing, effective May 27, 2023, as requested.<sup>1</sup>

The filings were publicly noticed. No protests or adverse comments were filed.
