Dear Secretary Bose:

On March 5, 2021, the California Independent System Operator Corporation (CAISO) filed a revised Transmission Control Agreement (TCA) to: (1) add Morongo Transmission LLC (Morongo) as a new participating transmission owner (PTO); and (2) update the list of contractual entitlements for Southern California Edison Company (SCE) to recognize Morongo's interest in the West of Devers Upgrade Project (Project). The CAISO requested an effective date of May 6, 2021 for the TCA revisions but also requested that, if the energization date of the Project and the execution by Morongo and SCE of the transfer capability lease for the Project were to occur after May 6, the Commission direct the CAISO to submit a further filing to revise the effective date of the TCA revisions necessary to add Morongo as a new PTO.¹

By order issued May 5, 2021, the Commission accepted the TCA revisions effective May 6, 2021 as requested by the CAISO. The Commission stated that if the CAISO requires a later effective date for the TCA revisions necessary to add Morongo as a new PTO, in the event that the signing of the transfer capability lease occurs after May 6, the CAISO must make a compliance filing to specify that effective date within 30 days of the actual closing date.²

The transfer capability lease for the Project was effective July 12, 2021.³ Accordingly, the CAISO is submitting this informational filing to specify an effective date of July 12, 2021 for the TCA revisions accepted by the Commission that are necessary to add Morongo as a new PTO.
