Dear Secretary Bose:

The California Independent System Operator Corporation submits for Commission filing and acceptance the instant filing under Commission eTariff Filing Type Code 370, solely for the purpose of establishing a new "Tariff Identifier," under which it will be making all its non-conforming service agreement filings. The ISO has already made a baseline filing of its tariff under another Tariff Identifier, and another baseline filing establishing a second Tariff Identifier for its rate schedule filings. The ISO expects that this third Tariff Identifier will be the last it will need to establish.

On the advice of Commission staff, the ISO is submitting a single blank tariff record in this filing to establish its non-conforming service agreement Tariff Identifier. The ISO will use this Tariff Identifier to bring all of its non-conforming service agreements together in a single location in the Commission's public viewer, separate from its tariff and its rate schedules. While the ISO is not including any actual service agreements in the instant filing, it expects to begin making service agreement filings under this Tariff Identifier within the next several days, and it intends to continue to use this Tariff Identifier for all its non-conforming service agreement filings from this point on.
