Dear Secretary Bose:

On March 26, 2021, the California Independent System Operator Corporation (CAISO) filed a tariff amendment to prepare for summer 2021 (Summer Readiness Tariff Amendment). By order issued May 25, 2021, the Commission accepted the Summer Readiness Tariff Amendment and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation.¹

The CAISO implemented the Summer Readiness Tariff Amendment on June 15, 2021. Accordingly, the CAISO is submitting this informational filing to specify an effective date of June 15, 2021 for the tariff revisions accepted by the Commission in this docket.²

Cal. Indep. Sys. Operator Corp., 175 FERC ¶ 61,160 (2021). The Commission directed the CAISO to notify the Commission of the actual effective date of the tariff revisions within five business days of their implementation, in an eTariff submittal using Type of Filing Code 150 – Report.

Specifically, this informational filing updates the effective date for the Tariff Records submitted in the initial Summer Readiness Tariff Amendment filing on March 26, 2021 in this docket. The CAISO is submitting the informational filing in eTariff using Type of Filing Code 150.
