**Amendment to Pending Filing and Informational Filing updating
the Effective Date of the Recollation Filing – 1 of 2**

Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act,¹ and Part 35 of the Federal Energy Regulatory Commission's (Commission) Regulations,² the California Independent System Operator Corporation (CAISO) submits this supplement to the May 26, 2023 Recollation Filing - Filing 1 of 2.³

As part of the original filing, the CAISO electronically filed several existing tariff records to update their collation values. The CAISO discovered it failed to properly map one tariff record properly. With this amendment, the CAISO seeks to withdraw the pending record for Appendix S, Section 1.4 and submit a revision to map it properly to its parent record.

The CAISO also requested an effective date of the last effective date for each tariff record in its original filing. With this amendment filing, the CAISO seeks to revise the requested effective dates for all eTariff records included in the filing to May 27, 2023, the day after the original filing.

Finally, the CAISO seeks waiver of the 60-day notice period and requests a shortened 10-day notice period.⁴ Granting such a waiver will not affect market participants because this filing does not change any tariff language or rate. It only allows for more space in the CAISO's Open Access Transmission Tariff (OATT) database to ensure the CAISO can continue to add new tariff records in future filings. The waiver will also allow the Commission to act on the recollation requested in this immediate docket and related Docket No. ER23-1978, which similarly requests the reassignment of the collation values for additional tariff records.
