> Re: California Independent System Operator Corporation Docket No. ER15-850-Informational Filing – EIM Administrative Charge Resettlement

Dear Secretary Bose:

The California Independent System Operator Corporation (CAISO) hereby submits information concerning the amount of EIM administrative charges that were resettled in compliance with the Commission's order in the above referenced docket.¹ Specifically, the Commission directed the CAISO to submit an informational filing within 30 days of the implementation of the EIM administrative charge resettlement, including the implementation date of the resettlement and the amounts that were resettled.

The Commission accepted changes to the EIM administrative charge effective January 15, 2015. The CAISO deployed the settlement system configuration to implement the change in the EIM administrative charge on March 25, 2015. PacifiCorp was the scheduling coordinator for the EIM entity and all EIM participating resources during the resettlement period from trading days January 15 until March 23.

Settlement for the period March 16 until March 23, as well as all trade days since, was reflected on the initial invoices issued by the CAISO and settled accordingly. Invoices issued between January 15 and March 16 were resettled pursuant to the CAISO's settlement statements issued 55 business days after the initial trading day (T+55B). The last T+55B resettlement invoice was issued on June 2 for trading day March 16, which concluded implementation of the resettlement.

The amount of EIM administrative charges that would have been due for trading days January 15 through March 23 under the previous rule is \$761,794.71. The amount

of EIM administrative charges for this period pursuant to the resettlement is \$370,696.58. The difference between the original amount and the resettlement amount is \$391,098.13.

On June 15, 2015, the CAISO proposed an amendment in Docket No. ER15-1919-000 to align the EIM administrative charge with the CAISO's grid management charge effective October 1, 2015. If accepted by the Commission, EIM administrative charges would be calculated as of the effective date to reflect that proposal.
