Constraint Tariff Amendment**

Dear Secretary Bose:

On March 10, 2022, the California Independent System Operator Corporation (CAISO) proposed a tariff amendment to increase the existing scheduling parameter values associated with intertie transmission constraint relaxation in both the residual unit commitment (RUC) and real-time market (RTM). By order issued May 20, 2022, the Commission accepted these tariff amendments and directed the CAISO to submit an informational filing to inform the Commission of the actual effective date within five (5) business days of implementation of the tariff changes.<sup>1</sup>

The CAISO implemented the tariff changes on June 1, 2022 and is submitting this informational filing to specify this effective date for the tariff revisions accepted by the Commission in this docket.<sup>2</sup>
