Dear Mr. Ulmer:

On January 28, 2009, the California Independent System Operator Corporation (CAISO) filed revised tariff sheets¹ in compliance with the Commission's order issued December 30, 2008 in Docket No. ER09-169-000.² In the December 30th Order, the Commission directed CAISO to: (1) replace the reference to "Applicable Reliability Criteria" with the phrase "NERC and WECC reliability standards, including any requirements of the NRC", and (2) include language that provides that the CAISO shall consider reasonableness and cost-effectiveness in the development of Ancillary Service standards. The revised tariff sheets satisfactorily comply with the Commission's December 30th Order and are accepted for filing, as designated, effective January 1, 2009, for the CAISO's pre-MRTU tariff and March 31, 2009 for the CAISO's MRTU tariff, consistent with the effective dates established in the December 30th Order.

The filing was noticed on February 23, 2009, with protests, comments, or motions to intervene due on or before March 2, 2009. No protests or comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.
