Dear Mr. Ivancovich:

On January 29, 2007, as amended February 2, 2007, the California Independent System Operator Corporation (CAISO) submitted revised tariff sheets in accordance with the Commission's December 28, 2006 order in this proceeding. The Commission's order required that the CAISO correct the modifications to section 9.3.10.5 of its tariff in order to include the clarification that forced outages must occur for fifteen minutes or more for the outage reporting requirement to be applicable. The instant submittal makes

the corrections required by the December 28, 2006 order. Accordingly, the filing satisfactorily complies with the Commission's order and is accepted, as designated, effective as provided in the December 28 Order.<sup>2</sup>

Also in the instant submittal, the CAISO has made corrections to certain non-rate terms and conditions associated with the tariff modifications accepted by the December 28 Order. Specifically, the CAISO points out that, in making the corrections required by the December 28 Order, it became aware of two clerical errors in its previous filed tariff sheets that are contrary to the purpose of the changes accepted by the December 28 Order. The proposed corrections are also accepted, as designated, effective as provided in the December 28 Order.

The January 29 filing was noticed on January 30, 2007, with comments, protests, or motions to intervene due on or before February 19, 2007. The February 2, 2007 amendment was noticed on February 8, 2007, with comments, protests, or motions to intervene due on or before February 23, 2007. No protests or adverse comments were received. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R. § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.

This acceptance for filing shall not be construed as constituting approval of the referenced filing or of any rate, charge, classification or any rule, regulation or practice affecting such rate or service provided for in the filed documents; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or any which may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against the California Independent System Operator Corporation.

This action is taken pursuant to authority delegated to the Director, Division of Tariffs and Market Development – West, under 18 C.F.R. § 375.307 of the Commission's regulations. This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
