The California Independent System Operator Corporation ("ISO") hereby submits for filing Certificates of Concurrence with respect to the Large Generator Interconnection Agreements among (1) Alta Wind Q97, LLC, Southern California Edison Company ("SCE"), and the ISO ("Q97 LGIA"), and (2) Alta Wind Q153, LLC, SCE, and the ISO ("Q153 LGIA").

I. Overview and Designated Filer

On February 7, 2014, SCE submitted the Q97 LGIA and Q153 LGIA in Docket No. ER14-1287-000, with a requested effective date of April 9, 2014. SCE's filing is pending before the Commission.

Rather than filing duplicate versions of the Q97 LGIA and the Q153 LGIA under the ISO tariff, the ISO is submitting the concurrence tariff records attached to this filing. The concurrence tariff record for the Q97 LGIA is designated as Service Agreement No. 2970 under the ISO tariff. The concurrence tariff record for the Q153 LGIA is designated as Service Agreement No. 2971 under the ISO tariff.

The ISO submits this filing pursuant to Sections 35.1 and 131.52 of the Commission's regulations, 18 C.F.R. §§ 35.1, 131.52.

Also, to the extent that the enclosed materials and information do not meet the detailed filing requirements of Part 35 of the Commission's regulations, the ISO respectfully requests that the Commission grant any necessary waivers.
