Meeting Minutes Review and Updates

Starting with trade date January 1, 2019, the ISO published both the Day-Ahead and Real-Time market report in a new HTML format. Beginning on January 1, 2019, the ISO implemented changes to the CRR settlements, the new day-ahead daily market watch report contains new metrics related to the CRR markets.

Weekly Market Performance Report

For December 25, 2018 – January 8, 2019 the markets were generally quiet and there were very few price excursion due load conditions and very few outages in the system due to load conditions.

Questions on the Updates or Weekly Market Performance Report

Q: What is the Malin500 constraint now showing up as MALIN500_ISL and not MALIN500? Is MALIN500_ISL the same constraint with the same limit?

A: The MALIN500_ISL is the same as MALIN500. The ISO recently made changes to its ETCC application and this naming convention more accurately describes Malin500 as an Intertie Scheduling Limit as opposed to other interties which are ITCs or Intertie Transmission Constraints.

Q: Will the ISO report on settled day-ahead congestion rents by constraint name?

A: The ISO will consider adding this information to the daily market watch report by second week of February.

Q: On the new Day-Ahead Daily Market Watch, is the unit \$/MWh incorrect and should be \$/MW? **A:** It is correct and should be \$/MWh.

Q: Can the ISO provide a manual to explain the new CRR metrics?

A: There is training material on CRR Track 1a and Track 1b the ISO Learning Center on the caiso.com website.

Q: What was the cause of the January 2 Ancillary Service scarcity events?

A: A large generator experienced a forced outage.
