Introduction

The Market Quality and Renewable Integration division publishes a Daily Exceptional Dispatch report for each trading day. The ISO currently provides information about the volumes and reason of exceptional dispatch instructions in the monthly performance reports and in the market performance forums. Such reports are issued once a month and every two months, respectively. In order to provide the market with more timely information about exceptional dispatches, this daily report provides market participants with data on the volume of exceptional dispatch and the associated reason pertinent to the trading day in the ISO balancing authority area. Generally this report is updated every day and there are three days lag for this report due to data availability. The Daily Exceptional Dispatch Metric Catalog provides a description of this report.

Daily Exceptional Dispatch Volume and Reason

The daily report consist of one single table. Table 1 shows a sample of the daily exceptional dispatch issued in the ISO balancing authority area. The table lists the volume in Megawatt hours (MWh) with associated reasons. The column "REASON" shows the reason for issuing the exceptional dispatch and the column "MWH" shows the exceptional dispatch volume for the associated reason accrued during the trading date.
