

PUBLIC SESSION MINUTES RC WEST OVERSIGHT COMMITTEE MEETING November 19, 2019 Teleconference

PUBLIC SESSION

The following agenda items were discussed in public session:

DECISION ON CHAIR AND VICE CHAIR TERMS

Michelle Cathcart, Vice President – Transmission System Operations for Bonneville Power Administration and Chair – RC West Oversight Committee, described proposed changes to the RC West Oversight Committee guidelines for chair and vice chair terms, which include the removal of staggered terms. Discussion ensued and Chair Cathcart clarified that the proposed changes would remove staggered terms for the chair and vice chair. She explained that elections for both the chair and vice chair would be held in May and results would be effective in June. There were no objections to the proposed changes.

Chair Cathcart next read a Resolution of Appreciation for Steven Cobb. Brief discussion followed.

OPERATIONS UPDATE

Tim Beach, Director – Reliability Coordination, Dede Subakti, Director – Operations Engineering Services, and Nancy Traweek, Executive Director – System Operations, provided updates regarding RC operations, including November go-live, phasor measurement unit, EHV data pool closure, and RC metric development. Discussion followed.

TECHNOLOGY UPDATE

Hani Alarian, Executive Director – Power Systems Technology Operations, provided updates regarding HANA ICCP tags and the network model schedule.

Brief discussion ensued regarding the December 2019 meeting of the RC West Oversight Committee and its 2020 meeting schedule. Committee members agreed to hold the December 2019 meeting as a webinar.
