





TRANSMISSION MAINTENANCE COORDINATION COMMITTEE (TMCC) MINUTES October 16, 2018

Meeting from the ISO Headquarters Folsom, California

Opening Comments:

Tibor Foki (IBEW 47) began a discussion on current industry news. The discussion focused in the following points;

CAISO presentation on Reliability Coordination:

Arthur Saenz and Robert Cristillo, of the CAISO, presented on the California ISO progress in becoming certified as a reliability coordinator (RC). Arthur and Robert described the make up and experience of the current RC team. They provided an update on which Balancing Authorities (BA) have committed to the CAISO RC, the Southwest Power Pool RC and the BAs that are undecided. Lastly, they provided an overview of the timeline in implementing the RC services to the CAISO footprint and the Expanded footprint.

Decision on 4/19/18 General Session Minutes:

The April 19, 2018 meeting minutes were reviewed and approved with no objections noted.

Decision on 6/13/18 Conference Call Minutes:

The June 13, 2018 meeting minutes were reviewed and approved with no objections noted.

NERC Reliability Standards and compliance processing:

The membership shared their experiences from thie years WECC audits

- SCE noted that the auditors were focused on processes and procedures, details and specifics and process controls.
- PG&E stated that their experience was similar
- Both the CAISO and SDG&E have audits in the next few weeks.
- WAPA SNR finished their audit in April 2018.

Briefing on major grid events:

PG&E discussed their recent decision to de-energize lines in the Sierra Foothills. They reported that 9 transmission lines and 57 distribution lines were de-energized for upto 72 hours affecting roughly 62,000 customers. PG&E noted that the wind storm they were tracking was less severe than predicted but was longer in duration than expected.

SDG&E commented that they are currently under Red Flag conditions and have de-energized some lines affecting roughly 1000 customers.

Open discussion items:

Acting TMCC Chairperson Steve Rutty summarized recent legislative bills and the group discussed the potential impact to TMCC membership;

Acting TMCC Chairperson Steve Rutty informed the members that Citizens Sycamore-Penasquitos Transmission LLC will be a new PTO joining this year.

Steve Rutty asked the members to work with the CAISO over the next few months to decide which topics they would like to discuss at the next TMCC meeting. Suggestions provided at the meeting included an update on SDG&E's fire hardening of their system, PG&E's installation of a 200 MW battery at Marsh Landing and CPUC updates to emergency preparedness and modifying GO95 climbing clearances.
