Filing, the California Independent System Operator Corporation ("ISO") hereby

II. BACKGROUND

On September 27, 2001, San Diego Gas & Electric Company ("SDG&E") tendered for filing copies of its Service Agreements Nos. 11 and 12 to SDG&E's FERC Electric Tariff, First Revised Vol. No. 6. These agreements relate to the interconnection to SDG&E transmission system of a new generation plant to be owned by CalPeak Power-Border, LLC ("CalPeak Border"). Service Agreement No. 11 is the Expedited Interconnection Facilities Agreement dated September 24, 2001 between SDG&E and CalPeak Border under which SDG&E will construct, operate and maintain the proposed interconnection facilities. Service Agreement No. 12, the Interconnection Agreement between SDG&E and CalPeak Border dated September 24, 2001, establishes interconnection and operating responsibilities and associated communications procedures between the parties.

To begin operation of its generating plant on September 30, 2001, CalPeak Border has advised SDG&E that it will need the interconnection facilities to be in service by September 24, 2001. For that reason, SDG&E submitted the agreements in unexecuted form, noting however, that the parties have agreed upon the agreements and that SDG&E anticipates that the agreements will be executed in California on or about September 24, 2001. SDG&E requests the Commission to grant waivers as are necessary to make the agreements effective on September 24, 2001.

The agreement, among other terms and conditions, provide for the physical interconnection of the CalPeak Border project to the SDG&E Electric System which in turn is connected with the ISO Controlled Grid.

III. BASIS FOR MOTION TO INTERVENE

The ISO is a non-profit public benefit corporation organized under the laws of the State of California and responsible for the reliable operation of a transmission grid comprising the systems of Pacific Gas and Electric Company, Southern California Edison Company and SDG&E. Inasmuch as SDG&E proposes the CalPeak Border project be interconnected to the SDG&E Electric System which in turn interconnects and affects the ISO Controlled Grid, the ISO believes that it has a unique interest in any Commission proceeding concerning the agreement submitted. Accordingly, the ISO requests that it be permitted to intervene herein with full rights as a party.

The ISO reserves the right to raise substantive issues regarding any further aspects of the proceeding ordered by the Commission. The ISO also reserves the right to file supplemental comments if warranted.

IV. CONCLUSION

Wherefore, for the foregoing reasons, the ISO respectfully requests that the Commission permit it to intervene and that the ISO be accorded full party status in this proceeding.
