# MOTION TO INTERVENE OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

Pursuant to Rule 214 of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. §§ 385.214, and the Commission's December 29, 2004 Notice of Filing, the California Independent System Operator Corporation ("ISO") submits this Motion to Intervene in the above captioned proceeding. In support thereof, the ISO states as follows:

#### I. DESCRIPTION OF THE PROCEEDING

On December 22, 2004, Reliant Energy Etiwanda, Inc., (Etiwanda) tendered for filing a letter agreement (Waiver Letter) setting forth certain waivers that affect its Rate Schedule FERC No. 2, Must-Run Service Agreement.

Etiwanda states that the Waiver Letter waives certain provisions of the Must-Run Service Agreement in light of Etiwanda's execution of a multi-year tolling agreement with Southern California Edison Company to commence January 1, 2005. Etiwanda requests that this filing be made effective January 1, 2005.

By its Notice issued December 29, 2004, the Commission established January 12, 2005, as the date motions to intervene are to be filed in the above-captioned proceeding.

#### II. DESCRIPTION OF THE ISO AND COMMUNICATIONS

The ISO is a non-profit public benefit corporation organized under the laws of the State of California with a principal place of business at 151 Blue Ravine Road, Folsom, CA 95630. The ISO is the Control Area operator responsible for the reliable operation of the electric grid comprising the transmission systems of a number of utilities including Southern California Edison Company ("SCE"), as well as the coordination of the ancillary services and real-time electricity markets in California.

#### III. ISO'S INTEREST

Etiwanda's RMR Units are located within SCE's transmission system and are needed to maintain the reliability of the ISO Controlled Grid. As the Control Area operator and as the counter party to the RMR Agreement, the ISO has a unique interest in any Commission proceeding that affects an RMR Agreement.

Accordingly, the ISO has a direct and substantial interest in this proceeding and requests that it be permitted to intervene. Because no other party can adequately represent the ISO's interests in this proceeding, the ISO's intervention is in the public interest and should be granted.

### IV. CONCLUSION

For the foregoing reasons, the ISO respectfully requests that the Commission grant this Motion to Intervene and make the ISO a party in the above-caption proceeding with full rights of participation.
