# MOTION TO INTERVENE OUT-OF-TIME OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

Pursuant to Rule 214 of the Rules of Practice and Procedure of the

Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. § 385.214,

and the Commission's January 15, 2003 Notice of Filing, the California

Independent System Operator Corporation ("ISO") hereby moves to intervene

#### II. BACKGROUND

On January 15, 2003, Pacific Gas and Electric Company (PG&E) tendered for filing proposed changes in its Transmission Owner Tariff (TO Tariff) and Cost Support for PG&E specific rates associated with the TO Tariff. PG&E requests that its filing be made effective upon the end of the 60-day prior notice period specified in Section 18 CFR 35.3.

By its Notice issued January 15, 2003, the Commission established February 3, 2003 as the date motions to intervene are to be filed in the abovecaptioned proceeding.

#### III. BASIS FOR MOTION TO INTERVENE

The ISO is a non-profit public benefit corporation organized under the laws of the State of California and responsible for the reliable operation of a grid comprising the transmission systems of Pacific Gas & Electric Company, Southern California Edison Company, San Diego Gas & Electric Company and the Cities of Vernon, Anaheim, Azusa, Banning and Riverside, California. Because PG&E is a Participating Transmission Owner and its revenue requirement is reflected in the ISO's Transmission Access Charge, the ISO has a unique interest in any Commission proceeding concerning the issues raised in the captioned proceeding.

Due to the press of a number of significant regulatory matters, the ISO was unable to file its interventions in a timely manner. The ISO requests that it be allowed to intervene out-of-time because it has a significant interest in this

matter, and its unique interest cannot be adequately represented by any other party. A late-filed intervention by the ISO should not prejudice any party or delay the proceedings herein because such proceeding is in the infant stages and the Commission has not yet issued an order on PG&E's filing.

### IV. CONCLUSION

For the foregoing reasons, the ISO respectfully requests that the Commission permit it to intervene, and that the ISO be accorded full party status in this proceeding.
