Basis for Intervening:

Pursuant to Rules 212 and 214 of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission (‘FERC’ or ‘Commission’), 18 C.F.R. §§385.212, 385.214, the Department of Market Monitoring (‘DMM’), acting in its capacity as the Independent Market Monitor for the California Independent System Operator Corporation (‘CAISO’), submits

this motion to intervene in this proceeding. DMM respectfully requests that the Commission afford due consideration to this motion to intervene, and afford DMM full rights as a party to this proceeding. The mission of DMM, as prescribed in the CAISO tariff pursuant to the Commission's Order 719, is "To provide independent oversight and analysis of the CAISO Markets for the protection of consumers and Market Participants by the identification and reporting of market design flaws, potential market rule violations, and market power abuses." The CAISO tariff further states that "DMM shall review existing and proposed market rules, tariff provisions, and market design elements and recommend proposed rule and tariff changes to the CAISO, the CAISO Governing Board, FERC staff, the California Public Utilities Commission, Market Participants, and other interested entities." As this proceeding involves CAISO tariff provisions which affect the efficiency and potential for market power in the CAISO markets, it implicates matters within DMM's purview.
