Dear Secretary Boergers:

Enclosed for filing please find an original and fourteen copies of a Notice of Implementation regarding non-payment for uninstructed deviations from awarded Ancillary Services capacity (the "No-Pay" rule) of the California Independent System Operator Corporation ("ISO"). The enclosed Notice of Implementation was issued by the ISO on September 1, 2000. The filing of this notice is being made for the information of the Commission.

The No-Pay rule was proposed and approved by the Commission in its orders concerning Amendment Nos. 13 and 14. *See California Independent System Operator Corporation*, 86 FERC ¶ 61,122, 61,417-19 (1999) (Amendment No. 13 order); *California Independent System Operator Corporation*, 87 FERC ¶ 61,208, 61,810-11 (1999) (Amendment No. 14 order). As described in the enclosed notice, implementation was delayed for software

reasons, and has been tied to the implementation of ten-minute markets since March of this year. The Commission accepted the ISO's ten-minute market proposal in its order on Amendment No. 29, conditioned upon the ISO's extending an exemption from the No-Pay rule to all Participating Loads that execute a Participating Load Agreement. *California Independent System Operator Corporation*, 91 FERC ¶ 61,324, 62,119 (2000).²

On August 22, 2000, the ISO issued notice that ten-minute markets would be implemented on September 1, 2000, pursuant to the Commission's order on Amendment No. 29. The ISO filed this notice with the Commission on August 23, 2000. The notice concerning ten-minute markets did not mention the No-Pay rule. Thus, the ISO decided to delay implementation of the No-Pay element of ten-minute markets for an additional ten days until Trade Day September 10, 2000. The ISO announced this September 10 implementation date in the enclosed notice.

The ISO states that the enclosed Notice of Implementation was posted on the ISO Home Page on September 1, 2000, and was sent to all Market Participants via e-mail on that same date. The ISO further states that it has served the Notice of Implementation upon each person designated on the official service lists for the above-referenced dockets, as indicated in the attached certificate of service.

The exemption described above applied to Participating Loads taking part in the ISO's Summer 2000 trial program. This trial program terminates on October 15, 2000. In evaluating its experience with the Summer 2000 trial program, the ISO will also evaluate the need for a continued exemption from the No-Pay rule for Participating Loads.
