**NOTICE OF WITHDRAWAL

Pursuant to Rule 216 of the Rules of Practice and Procedure of the Federal Energy Regulatory Commission (“Commission”), 18 C.F.R. § 216 (2004), the California Independent System Operator Corporation (“CAISO”) hereby provides notice of withdrawal of the CAISO’s protest filed in the above-captioned proceeding on October 12, 2000.

The CAISO’s protest concerned whether Geysers Power Company, LLC (“Geysers”) had correctly calculated refunds owing in its Final Refund Report filed in the above-captioned docket on September 15, 2000. As described in the CAISO’s and Geysers’ joint response to the June 1, 2005 letter from the Commission requesting a status report filed this day, the CAISO and Geysers have resolved all outstanding issues. Accordingly, the CAISO now withdraws its


