## ANSWER OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

The California Independent System Operator Corporation ("CAISO") submits this answer to the comments filed in this proceeding on November 13, 2015, by the Cities of Anaheim, Azusa, Banning, Colton, Pasadena, and Riverside, California (the "Six Cities").

The Six Cities filed comments on the CAISO's October 26, 2015, filing to remove tariff provisions allowing convergence bidding on the interties in compliance with the Commission's September 25, 2015, order in this proceeding. No party opposed the CAISO's compliance filing. Six Cities agree with the tariff revisions proposed in the CAISO's October 26 filing, but suggests that one additional modification to section 31.8.2 of the CAISO tariff is appropriate to comply fully with the September 25 order and avoid ambiguity. Specifically, Six Cities propose moving the phrase "which can be physical or virtual" within this section.

The CAISO does not believe the modification proposed by Six Cities is necessary to comply with the Commission's directives. The CAISO tariff is clear that

convergence bidding is no longer permitted on the interties without this change. The CAISO has no objection, however, to making the change to section 31.8.2 suggested by Six Cities if directed to do so by the Commission.

The CAISO respectfully requests that the Commission take this answer into account and accept the October 26 compliance filing
