## Re: California Independent System Operator Corporation Compliance Filing to Reflect Effective Date of Natural Gas Price Index Tariff Provisions Accepted in the Commission's June 1, 2016 Order Docket No. ER16-1649-

Dear Secretary Bose:
The California Independent System Operator Corporation (CAISO) submits this filing in compliance with the Federal Energy Regulatory Commission's (Commission) "Order Granting Petition for Extension of Limited Waiver and Dismissing Motion for Clarification," issued in this proceeding on October 20, 2016. ${ }^{1}$

The October 20 Order granted the CAISO's petition for a limited tariff waiver, and approved the CAISO's use of the Intercontinental Exchange gas price index as it met the requirements of the Policy Statement, permitting the CAISO to implement certain related tariff provisions on October 22, 2016. ${ }^{2}$ The October 20 Order also directed the CAISO to reflect the actual effective date of the new natural gas price index provisions.

The CAISO hereby submits this compliance filing consistent with the Commission's directive. Specifically, the CAISO resubmits sections 39.7.1.1.1.3(a)-(b), 30.4.1.2(b), and 31.6.1(v), with a new effective date of October 22, 2016. CAISO also notes that tariff sections 39.7.1.1.1.3(c)-(d) have retained the July 6, 2016 effective date. ${ }^{3}$

The purpose of this filing is only to revise the effective date for the affected tariff records and no tariff language is being changed. Accordingly, no clean or marked tariff attachments are included with this filing.
