> **California Independent System Operator Corporation** Compliance Filing to Reflect Effective Date of the Flexible Ramping **Product Tariff Amendment to November 1, 2016** Docket No. ER16-2023-

Dear Secretary Bose:

The California Independent System Operator Corporation (CAISO) submits this filing in compliance with the Federal Energy Regulatory Commission's (Commission) October 20, 2016, order: (1) granting the CAISO's petition for limited tariff waiver allowing the CAISO to modify the effective date to November 1, 2016, of tariff provisions implementing the new flexible ramping product (FRP) previously accepted by the Commission,² and (2) directing the CAISO to file revised tariff records to reflect the new effective date within fifteen days of the order.³ Specifically, all tariff revisions accepted by the Commission in the September 26 Order in this proceeding are made effective November 1, 2016.

It should be noted that some sections included in the eTariff tariff records containing the accepted FRP tariff revisions have been revised in other proceedings that have become effective since the October 1 effective date proposed in the original FRP amendment filing. The tariff records for this filing have been updated to include all such language currently effective as of November 1, 2016; none of the revisions accepted in other proceedings directly overlaps or conflicts with the FRP tariff revisions,⁴ and the CAISO does not propose any changes to the tariff language as accepted by the Commission in any of those other proceedings.

ER16-1518-001 and ER17-40-000.
