Reference: Revisions to Participating Load Agreement

On September 11, 2019, the California Independent System Operator Corporation (CAISO) filed revisions to a Participating Load Agreement (Agreement) with California Department of Water Resources State Water Project (SWP). The revisions extend the termination date of the Agreement from November 1, 2019 to November 1, 2021. Waiver of the Commission's notice requirements pursuant to section 35.11 of the Commission's regulations (18 C.F.R. § 35.11) is granted,¹ and the revisions are accepted for filing, effective November 1, 2019, as requested.²

This filing was noticed on September 11, 2019, with comments, protests, or motions to intervene due on or before October 2, 2019. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and
