Re: California Independent System Operator Corporation Amendment to Pending Filing to Correct eTariff Record Docket No. ER18-1-___

Dear Secretary Bose:

On September 29, 2017,¹ the California Independent System Operator Corporation (CAISO) submitted pursuant to Section 205 of the Federal Power Act² and Part 35 of the Commission's Regulations³ a tariff amendment to implement six discrete, stand-alone tariff changes that arise from the CAISO's reliability services initiative, Phase 1B and Phase 2. The CAISO has since discovered that an incorrect tariff record was provided as part of the eTariff filing. The clean and marked tariff sheets attached to the filing reflect the intended tariff provisions and the CAISO has not identified any errors in the publicly available materials included as part of the September 29 filing.

Due to clerical error, tariff section 43A.4.2 was not included in the eTariff filing, and the record for section 43A.2.7 was inadvertently attached in its stead. The CAISO makes this filing to correct that error and provide the correct eTariff record for tariff section 43A.4.2. The CAISO apologizes for any inconvenience this error may have caused and respectfully requests that the Commission allow the eTariff record to be replaced.

The CAISO is not providing additional clean and marked tariff sheets, or any other attachments to this filing because, as noted, the correct tariff language was properly reflected in the initial filing attachments.

The CAISO has served the California Public Utilities Commission, the California Energy Commission, all entities with a Scheduling Coordinator Agreement under the CAISO tariff, and any persons designated on the service

list for Docket No. ER18-1. The CAISO has posted this amendment to the pending filing on its website.

The CAISO respectfully requests that the Commission issue an order by December 15, 2017, accepting the proposed tariff changes made in both the initial filing and in this filing, be effective February 15, 2018.
