REQUEST FOR CLARIFICATION OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

Pursuant to Rule 212 of the Commission's Rules of Practice and Procedure, 18 C.F.R. §§ 385.212, the California Independent System Operator Corporation ("CAISO") submits this request for clarification of the Order Accepting Revisions to Transmission Control Agreement, *California Indep. System Oper. Corp.*, 117 FERC ¶ 61,029 (2006) ("TCA Order"). The CAISO needs guidance from the Commission regarding the intended effective date of the amendments to the Transmission Control Agreement ("TCA") accepted in the TCA Order in the event it may be able to avoid re-filing a significant number of revised tariff sheets for the TCA amendments.

In the CAISO's transmittal letter and in the footer of the revised tariff sheets for the filing of the proposed TCA amendments, the CAISO requested an effective date of October 10, 2006 for 119 of the 122 tariff sheets for the amendments – 60 days subsequent to the August 11, 2006 date of its filing of the amendments. Ordering paragraph (A) of the TCA Order states that the CAISO's proposed revisions to the TCA are accepted for filing "effective as requested," which the CAISO would ordinarily interpret to mean the requested date of October 10, 2006 for the 119 affected tariff sheets for the TCA amendments.

However, paragraph 18 of the TCA Order indicates that the 119 affected tariff sheets are accepted "to become effective October 11, 2006."

The CAISO requests the Commission to clarify whether it intended to accept the subject TCA amendments effective as of October 10, 2006, 60 days subsequent to the date of filing as requested by the CAISO, or October 11, 2006 as stated in paragraph 18 of the TCA Order. If the Commission intended the latter effective date, the CAISO will re-file the 119 affected tariff sheets for the TCA amendments with a footer showing an "Effective" date of October 11, 2006 instead of the date of October 10, 2006 shown on the tariff sheets currently on file with the Commission. Otherwise, the affected tariff sheets for the TCA amendments on file are correct, and the CAISO will make no further compliance filing in this proceeding.
