The California ISO issued a Significant Event Capacity Procurement Mechanism (CPM) designation to multiple generating units for a system reliability need. The designation is effective October 1, 2018, and has 30-day term.

Reason for CPM:

The ISO issued a Significant Event CPM designation in light of an alternate load forecast presented by California Energy Commission (CEC) staff. The initial load forecast was the basis of establishing resource adequacy requirements throughout the year. This alternate forecast is not officially adopted by the CEC. The Significant Event is expected duration to last until the end of the 2018 year.

Considering the differential in forecasts, along with the October RA showings, and the accepted 60-day extensions of the September significant event designations, the ISO concluded that it would designate up to 2,946 MW of additional capacity for the month of October.

The initial CPM term is for 30 days under the tariff, subject to adjustment and the payment provisions set forth in the CPM tariff provisions. Per section 43A.3.5 of the ISO tariff, the 30-day term may be extended for an additional 60 days if the ISO determines that the significant event will extend beyond 30 days. At this time the ISO does not expect to extend this initial 30-day term.
