Market Settlement User Group – 1/09 MSDC report

- 4Q 2018 Configuration release
 - Deployed to Production 12/27/18
 - Contained
 - CRR Auction Efficiency 1B (CRR 1B) initiative which takes effect 1/1/2019
 - EIM-SMUD Sub-BAA Enhancements, on logical meter calculation for system resources takes effect 4/1/2019
 - Implement resource-level RAAIM availability incentive mechanism exclusion flags
 - Update RAAIM neutrality PTB in CC 8835 (please refer to latest PRR 1098)
 - PC Spin and Nonspin NoPay, filter only to ISO BAA to conform with existing BPM



Market Settlement User Group – 1/9 MSDC report

- CRR 1B Enhancement –to be implemented in 2019 (before T+55)
 - CAISO will provide the following CRR-specific information in a new CMRI report, per binding constraint and time interval
 - CRR ID
 - Hedge Type (option or obligation)
 - CRR Type (LSE, AUC, etc.)
 - Hourly Notional Revenue
 - Hourly CRR ClawbackRevenue
 - Hourly Circular Scheduling Revenue
 - De-rate factor (applies to merchant TOR CRRs)
 - CRR award MW
 - This information will be provided for each CRR at a unique source and sink location. If an SC has multiple CRRs at the same source and sink, result will be based on the net award value
