Discussion: Chair and Vice Chair Term Limits



Elections

The RC West Oversight Committee members will elect a Chair and Vice Chair positions.

- Annual e Elections will be held to select Oversight members who will hold the Chair or Vice Chair positions. Each position will be for a two-year staggered term.
- Chair and Vice Chair positions will be approved by a majority vote of the Oversight Committee members for each position and based on the Voting Rule Procedure.
- Starting in 2020, Eelections will be held in MarchMay, with terms beginning in June.



Duration of Service

To transition to staggered terms, the elections will be as follows:

<u>March 2019</u>:

- The elected Chair and Vice Chair will each serve a oneyear term.
- <u>March 2020</u>:
- The elected Chair will serve a two-year term.
- The elected Vice Chair will serve a one-year term.

March 2021 and beyond:

 The expiring position of Chair or Vice Chair will be elected to serve a two-year term.

Development of RC West Metrics - Proposal

- Metrics for enhanced reliability services similar to Peak's
 - Peak reports this to its Board and the report is made available to <u>Public</u>
 - RC West will make this report to RC oversight committee <u>public</u> meeting
- Metrics for data input quality based on IRO-010 data requirements to support RC services
 - Peak produce this report only for each BA/TOP and it is <u>confidential</u> to the particular BA/TOP
 - RC West will do the same and treat it as confidential
- Metrics for internal RC West that measure the cross-department performance of the RC Operator, Operations Engineer and the IT Professional and IT computer systems
 - Peak does not produce this report externally
 - RC West is interested in the input from BA/TOP
