


- SE Residual Error MW flow on 500kV, 345kV, 230kV, 138kV, and 115kV lines
- Note: Residual flow is the difference between the calculated SE solution flow on each line compared to the actual telemetry value. This is a reflection of SE accuracy in RC West area.







RC Metrics Q2 2021 - RTCA Non-Converged Contingencies


- Average count of Real-Time Contingency Analysis (RTCA) non-converged contingencies in five-minute intervals divided by the total number of contingencies for that interval
- Note: Over 8,500 contingencies are solved in every RTCA solution






RC Metrics Q2 2021 - DACA Accuracy


Day Ahead Contingency Analysis (DACA) tool is designed to identify potential contingencies in the day ahead timeframe





RC Metrics Q2 2021 - CIDI/Issue Resolution Progress

- Count of Customer Inquiry and Dispute Information (CIDI) tickets of the RC Inquiry case record type
- The number of opened cases will not change each time the data is pulled, but the other numbers can change as there are still cases opened from a prior month that haven't been closed.
- The average business days with CAISO support numbers are not shown for Q2 due to an internal defect under assessment.
