Tagging Outage Saturday, 06/06/2020 12:08 PDT

SUBJECT: System Event on June 6th

Problem Descriptions:

At approximately 2:10 PM CPT on June 6th, OATI received reports that some systems were inaccessible to users. OATI Teams investigating found that a service running on the Domain Name Servers (DNS) in the Minneapolis Data Center was not functioning properly. By 3:06 PM CPT the DNS service was back online and the issue was resolved. The OATI Bloomington Data Center DNS was not impacted during this event.

OATI project teams continued to monitor the DNS and servers for the rest of the day.

Post Event Follow-up:

OATI identified the root cause of the outage was a failure in the OATI domain name resolution used by OATI applications from the Minneapolis Data Center at approximately 1:40 PM CPT. The DNS services were restarted at 3:06 PM CPT and the system issue was resolved.

OATI has implemented additional DNS service monitors that will automatically mitigate the situation under similar failure conditions. Additionally, OATI has escalated the details of this failure to the DNS software vendor for resolution.

OATI apologizes for the inconvenience this may have caused your organization and looks forward to working with you in the future.

Internet Service Outage 08/30/2020

CenturyLink Outage Impact

The August 30, 2020 CenturyLink ISP outage had significant impact on Internet traffic across the globe spanning many industries. This outage also impacted some of our customers, and OATI wants you to know that we stand ready to support you during these types of events, and that the OATI Private Cloud is designed to withstand such disruptive communications events.

This early Sunday morning event triggered OATI's escalated response team, comprised of senior staff from Customer Support, IT, Project Management, Integration, Development and Executive teams. Over 40 staff joined in activities via both on-site presence as well as web-meetings to coordinate and execute response activities. OATI Private Cloud Data Centers were not impacted by this event and OATI systems remained fully operational. OATI Data Centers have quadruple redundancy including use of Internet Service Providers. The OATI IT staff took precautionary action circumventing traffic through the degraded network. OATI responded to several customer tickets reporting connectivity problems from external networks, and worked with those customers to assist them in this issue. OATI staff appreciated the feedback from customers "Stressful event. Help desk very responsive and informative".

WIT Schedule Change Requests Guidelines

- WECC Inadvertent data report for the previous month must be sent to stakeholders after the 15th of the following month.
- Please make your changes prior to the 15th of the following month for the previous month
- Meter actual changes are processed directly in WIT within 168 hours. After 168 hours, work with OATI to fix the meter before the 15th of the following month.
- Please inform ATF Chair, SPPW and RCW administrators for any changes made to schedules or meter actuals after the 168 hours window expired.
- NERC/CERTS Inadvertent data for each month must be locked by the administrators after the 15th of the following month.
