New Default Energy Bid Option and Day Ahead Flexible Capacity Product Initiatives

Seattle City Light generally supports Powerex’s proposal to include a process for a new Default Energy Bid option for resources located outside of the CAISO footprint. Seattle City Light also supports Powerex’s proposal for an initiative regarding a day ahead flexible ramping capacity product and Public Generating Pool’s proposal for an initiative to more generally address market enhancements to make more flexible capacity available to the ISO, including a day ahead flexible ramping capacity product. Seattle City Light believes these proposals are important to market functionality and operational challenges facing the CAISO today and should be included in the stakeholder catalog process and initiated as soon as practical.

Resource Sufficiency Test Enhancements

Seattle City Light generally supports the inclusion of an initiative in the California ISO Policy Initiatives Catalog process that addresses issues associated with the EIM Resource Sufficiency Tests.

Please provide any data/information available that would characterize the importance or magnitude of the issue.

Both Powerex and the “EIM Entities” have independently requested an initiative to address issues with the Resource Sufficiency Test(s). The EIM Entities have specifically requested an initiative addressing the Flexible Ramping Sufficiency Test (“FRST”) while Powerex has requested a broader review of the suite of Resource Sufficiency Tests to be included as an initiative in the catalog process. Seattle supports the general idea that the Resource Sufficiency Tests could use enhancement and that this is a ripe issue to be addressed in the next initiative cycle.
