

IMPORTANT NOTE:

California ISO Conformed Tariff as of April 6, 2007

The Tariff is current through April 6, 2007. Currently effective language from Tariff Amendments and compliance filings, which FERC has approved, is shown in clean copy. Pending language from compliance filings that FERC has not ruled on as of April 6, 2007, but whose proposed effective date has already arrived, is shown in highlight.

Note that where such pending compliance filing language will supersede currently approved language, it will be necessary to consult previous versions of the Tariff to see the full text of the language superseded by the highlighted pending language.

The Tariff does not include Tariff Amendments submitted to the Commission but not yet approved.

This version updates the December 21, 2006 version of the Conformed Tariff to reflect:

- FERC's December 28, 2006 Order on the Outage Reporting Requirements Amendment (ER07-127), which accepted with modifications the ISO's October 31, 2006 amendment filing in that docket (see 117FERC¶61,353). The ISO submitted a filing in compliance on January 29, 2007. The approved and proposed language can be found on pages 163, 164, 164A, 165, 442A, 443 and 463L [These pages are contained in the PDF document below titled Sections 1-11 and Section 12-43, as well as in the Combined S&R Tariff PDF Document.]
- FERC's December 29, 2006 Order on the Participating Intermittent Resource Program Amendment (ER07-142), which accepted with modifications the ISO's November 1, 2006 amendment filing in that docket (see 117FERC¶61,356). The ISO submitted a filing in compliance on January 29, 2007.
