

**IMPORTANT NOTE:**

California ISO Conformed Tariff as of December 21, 2006

The Tariff is current through December 21, 2006. Currently effective language from Tariff Amendments and compliance filings, which FERC has approved, is shown in clean copy. Pending language from compliance filings that FERC has not ruled on as of December 21, 2006, but whose proposed effective date has already arrived, is shown in highlight.

Note that where such pending compliance filing language will supersede currently approved language, it will be necessary to consult previous versions of the Tariff to see the full text of the language superseded by the highlighted pending language.

The Tariff does not include Tariff Amendments submitted to the Commission but not yet approved.

This version updates the August 18, 2006 version of the Conformed Tariff to reflect:

- FERC's October 18, 2006 Letter Order in the Low Voltage Transmission Revenue Requirement Amendment (ER06-1395), which accepted the ISO's August 24, 2006 amendment filing in that docket; and the ISO's tariff changes to comply with FERC Order No. 676 (see 115 FERC 61, 102). The approved language can be found on pages 57, 57A, 57B, 327, 328, 328A, 515, 515A, 534, 534A, 745, 750, 752, 754, 754A and 754B. - FERC's August 25, 2006 Letter Order in the Amendment 72 Docket (ER05-1502), which accepted the ISO's June 12, 2006 compliance filing in that docket. - The ISO's Settlement and Amended Compliance Filing made on September 1, 2006 in the CDWR-SWP Docket (EL00-95-135) based on the ISO's August 5, 2005 Compliance Filing. The proposed language can be found on pages 151, 151A, 151B, 485 and 485A; as this filing has not been approved by FERC as of December 21, 2006, all of the proposed language is shown in highlight. - FERC's September 9, 2006 Letter Order in the GMC Rate Filing (ER06-1281), which accepted the ISO's July 16, 2006 GMC Rate filing in that docket. - The ISO's Compliance Filing made on October 20, 2006 in the Reliability Capacity Services Tariff Docket (EL05-146) in response to FERC's September 27 Order (see 116 FERC 61, 297). - The ISO's Compliance Filing made on July 21, 2006 to correct an error made to the conformed version of the S&R Tariff, filed on March 22, 2006 in ER05-1501-001 in response to the Commissions direction to change section 39.2 of the tariff in its order on Amendment No. 73, which raised the "soft" cap bids from \$150/MWh to \$400/MWh. FERC approved this compliance filing in its December 14, 2006 letter order. The proposed changes can be found on sheet no. 462. - The ISO's Compliance Filing made on October 25, 2006 in the Small Generator Interconnection Procedures Docket (ER06-629) in response to FERC's July 27 Order-B (see 116 FERC 61,046). The proposed language can be found on pages 1207-1249; as this filing has not been approved by FERC as of December 21, 2006, all of the proposed language is shown in highlight. - The ISO's Compliance Filing made on November 16, 2006 in the Large Generator Interconnection Agreement Docket (ER04-445-015) in response to FERC's November 1 Order (see 117 FERC 61,148). The effective date only was changed on page 1077; this filing has not been approved by FERC as of December 21, 2006. It should also be noted that there are five supplementary Tabs accompanying this Conformed Tariff. Tabs 1 and 2 were part of the August 18, 2006 version of the Conformed Tariff.

Tab 1 also contains proposed sheet designations from the Interim Reliability Requirements Program Docket (ER06-723) if FERC approves the ISO's alternative language.
- Tab 2 contains language that the ISO is proposing as alternative language to the Credit Policy Supplemental Compliance Filing made on August 9, 2006.
