Revisions to Transmission Control Agreement

Dear Secretary Bose:

The California Independent System Operator Corporation (CAISO) submits this filing in compliance with the Commission's August 30, 2018 order accepting revisions to the Transmission Control Agreement (TCA).¹

In the August 30 Order, the Commission accepted the CAISO's proposed revisions to the TCA to be effective either August 31, 2018 or the actual closing date between Citizens Sycamore-Penasquitos Transmission LLC (CSPT) and San Diego Gas & Electric Company (SDG&E), whichever is later.² The Commission directed the CAISO to submit a compliance filing to revise the effective date for changes to the CSPT Appendix A and SDG&E Appendix A to the TCA in the event the transaction between SDG&E and CSPT closed on a date other than August 31, 2018. The Commission further directed the compliance filing being due 30 days from the date of the actual closing date.³

On September 23, 2019, SDG&E notified the CAISO that it had transferred to CSPT, and CSPT had acquired from SDG&E, an entitlement portion of the Sycamore-Penasquitos 230 kV Transmission Line Project (Sycamore-Penasquitos Project), and that closing occurred as of September 23, 2019. Consistent with the August 30 Order, the CAISO submits the instant filing

to modify the effective date of CSPT Appendix A and SDG&E Appendix A to reflect the actual closing date of September 23, 2019.⁴
