## MOTION OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION FOR EXTENSION OF TIME

Pursuant to Rules 212 and 2008 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") Rules of Practice and Procedure, 18 C.F.R. §§ 385.212 and 385.2008 (2006), the California Independent System Operator Corporation ("ISO") respectfully requests an extension of time to submit its reply to the Commission's August 10, 2012 deficiency letter addressed to the ISO and to Southern California Edison Company. Specifically, the ISO requests an extension of time of seven calendar days to September 17, 2012 to provide its response to the deficiency letter.

## I. MOTION FOR EXTENSION OF TIME

The questions set out in the August 10, 2012 deficiency letter ask various technical questions regarding interconnection configuration, relating to the protection system consisting of fiber optic cables and associated protection equipment. The ISO requires further time to review the participating transmission owner interconnection facilities configuration and also to review the responsive information filed by Southern California Edison on September 7, 2012. The ISO submits that good cause exists for the extension in light of the fact that the subject matter concerns the classification and resulting cost responsibility of certain facilities classified as non-network, participating

transmission owner interconnection facilities. Such facilities are largely a subject matter between Southern California Edison and the interconnection customer, as such facilities are on the customer's side of the point of interconnection, and accordingly, the ISO

requires further time to review the materials related to such facilities. The ISO submits

that seven calendar days will provide adequate time for the ISO to do so and prepare its

response to the Commission's August 10, 2012 deficiency letter.

II. **CONCLUSION** 

For the reasons set forth above, the ISO respectfully requests that the Commission grant this motion for extension of time to file its response to the August 10,

2012 deficiency letter to September 17, 2012.
