## MOTION OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR FOR EXTENSION OF TIME

Pursuant to Rules 212 and 2008(a) of the Commission's Rules of Practice and Procedure, 18 C.F.R. §§ 385.212, 385.2008(a) (2007), the California Independent System Operator Corporation ("CAISO")<sup>1</sup> respectfully requests an extension of time until October 5, 2007 to comply with Paragraph 175 of the Commission order issued on June 25, 2007, in the above-captioned docket.<sup>2</sup>

#### I. Motion for Extension of Time

As required by Rule 2008(a), good cause exists to grant the CAISO the requested extension of time. In Paragraph 175 of the June 25 Order, the Commission directed the CAISO, upon completion of a stakeholder process, to submit revised tariff sheets reflecting the ability to allow Metered Subsystem ("MSS") resources to designate Reliability Must-Run ("RMR") Units as Loadfollowing. Pursuant to this directive, the CAISO has drafted proposed tariff language based largely on its discussions with the Northern California Power

California Independent System Operator Corp., 119 FERC  $\P$  61,313 (2007) ("June 25 Order"). In the "Notice of Extension of Time" issued on August 8, 2007, in the above-captioned docket, the Commission granted an extension of time until September 28, 2007, to comply with Paragraph 175 of the June 25 Order.

Agency ("NCPA"), the only Load-following MSS and the only MSS with an RMR Contract, concerning the most appropriate way to mesh the Load-following requirements and the RMR requirements. The CAISO has been working with NCPA productively. These discussions with NCPA are nearly completed. However, there is an implementation issue identified this week that the CAISO must resolve before it can finalize the proposed tariff language. NCPA was unavailable to discuss the issue toward the end of the current week. Therefore, the CAISO requests that the Commission grant an extension of time until October 5, 2007, for the CAISO to complete its discussions with NCPA and then submit the tariff language in compliance with Paragraph 175 of the June 25 Order.

#### II. Conclusion

For the reasons explained above, the CAISO requests that the Commission grant this motion for extension of time.
