STATUS UPDATE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION

As stated in its Motion to Intervene and Protest filed on October 22, 2001, in this proceeding, the California Independent System Operator ("ISO") hereby provides an update on its discussions with the Pacific Gas and Electric Company ("PG&E") regarding the Notice of Cancellation of a Reliability Must-Run ("RMR") Service Agreement ("RMR Agreement") between PG&E and the ISO for the FMC Synchronous Condenser/Emergency Gas Turbine ("FMC Unit"), a designated RMR facility.

On October 1, 2001, PG&E submitted a Notice of Cancellation of the RMR Agreement between PG&E and the ISO for the FMC Unit. The ISO protested the PG&E Notice of Cancellation, indicating that termination of the FMC Unit's RMR Agreement could mean that the ISO would have insufficient resources to satisfy reliability criteria in the San Jose area under some conditions during summer 2002, absent upgrades to the San Jose area transmission system, or the addition of new generation in the area by June 2002. The ISO indicated in its protest that it would discuss issues associated with the termination of the FMC Unit RMR Agreement with PG&E and update the Commission regarding the outcome of these discussions by November 22, 2001.

Unfortunately, the ISO has not yet resolved outstanding issues associated with termination of the FMC Unit RMR Agreement with PG&E. The ISO has communicated to PG&E the actions that must be taken by PG&E to assure reliable service in the San Jose area in the absence of the FMC Unit RMR Agreement. The ISO has indicated to PG&E that it would withdraw its protest to termination of the FMC Unit RMR Agreement upon obtaining agreement from PG&E to complete the following projects by June 2002:

- Facilitate the interconnection of Calpine's Los Esteros Critical Energy Facility
- Complete installation of a fourth 230-115kV transformer at Newark Substation
- Complete the reconductor of the San Jose-FMC 115kV line tap
- Develop and initiate a project to mitigate overloading of the Metcalf-Evergreen and Metcalf-El Patio 115kV lines by June 2003

To date, while it has had a cordial discussion with PG&E, the ISO has not received a firm commitment from PG&E to undertake these projects.

Accordingly, the ISO's October 21, 2001, protest cannot yet be withdrawn.
