UNOPPOSED MOTION OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION TO AMEND THE PROCEDURAL SCHEDULE

To: The Honorable Bobbie J. McCartney Presiding Administrative Law Judge

Pursuant to Rule 212 of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.212 (2000), the California Independent System Operator Corporation ('ISO") hereby moves to amend the Procedural Schedule established in this proceeding to accommodate the new hearing date of October 16, 2001. No party to the proceeding objects to this Motion.

I. Background

The ISO filed its unbundled Grid Management Charge ("GMC") with the Federal Energy Regulatory Commission ("Commission") on November 1, 2000. This filing was supplemented with Period II cost data and supporting testimony on December 15, 2000. On November 13, 2000, Pacific Gas and Electric Company ("PG&E") filed its proposed GMC pass-through Tariff, which was modified on December 26, 2000. The GMC and PG&E pass-through proceedings were consolidated by the Commission and set for hearing in an order issued December 29, 2000, and the consolidated proceeding was

assigned a Track 2 schedule by order of the Chief Judge dated January 8, 2001. The current procedural schedule was set by order of the presiding Administrative Law Judge on January 18, 2001.

On April 19, 2001, the ISO filed an unopposed motion to change the proceeding to a Track 3 schedule and requested a new hearing date of October 16, 2001. On April 24, 2001, the Chief Judge issued an order that, while retaining the Track 2 schedule with regard to the briefing and initial decision phases of the proceeding, postponed the hearing date to October 16, 2001, as requested by the ISO.

II. Proposed Changes to Procedural Schedule and Request for Waiver of Responses

The ISO proposes the following changes to the procedural schedule to accommodate the new hearing date:
