MRTU readiness includes ensuring that all necessary FERC filings are made and accepted

Pending tariff amendment filings

Tariff amendments to filed following Board authorization

Miscellaneous filings that do not require Board approval

60-day MRTU certification informational filing



The following MRTU filings are pending a FERC decision and are necessary for *go live*:

Miscellaneous amendments	December 21, 2007
Clean-up tariff compliance obligations	
Grid Management Charge for MRTU	February 20, 2008
Modification to decremental bidding rule	May 23, 2008
Compliance filing and rehearing request re cap on start up and minimum load costs	July 21, 2008
Rehearing request re allocation of uplift to metered sub systems	July 21, 2008



The following filings are necessary for MRTU go live:

Filings requiring Board authorization

Changes in conditions for modification of non-priced quantities by MRTU software

Includes compliance filing re clearing of demand in the dayahead market and scheduling and pricing parameters

Price caps and price floors for all MRTU products

Deferral or limitation of certain MRTU functionality

60-day MRTU readiness certification



The following additional filings are also necessary for MRTU *go live*:

Other filings that do not require Board authorization

Miscellaneous tariff clarifications

Opening the day-ahead market 7 days prior to February 1

Informational filing of MRTU tariff with January 31, 2008 date

OASIS waiver under MRTU to carry over current waiver

Calculation of available transmission capacity under MRTU

Informational filing of congestion revenue rights for go live

Replacing Blythe's firm transmission rights with merchant congestion revenue rights for *go live*

Metered sub system agreements

Big Creek physical scheduling plant agreement



60-day MRTU certification is an informational filing that will discuss the following:

- Overall Dashboard (People, Process, Technology)
- Status of MRTU Readiness Criteria
 - Internal Readiness ISO Business Unit assessment
 - External Readiness Feedback from Market Participant assessment
- Status of Market Simulation Exit Criteria
- Status of Market Certifications (SAIC, LECG, PWC)
- Status of FERC Filings and outstanding FERC Orders
- Remaining Activities and Milestones for go live



60-day certification will also include:

- Confirmation that ISO's software and systems are ready through statements by key Officers
- Assessment that system is effective when demand bids exceed supply bids
- Confirmation that MRTU can accommodate partial resource adequacy units
- Description of the ISO's contingency plans
- Mitigation actions for any readiness criterion
- Action plans to achieve internal and external readiness
