COMMENTS OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR ON USS POSCO INDUSTRIES' AND THE CALIFORNIA ENERGY COMMISSION'S PETITIONS TO MODIFY DECISION 01-04-006

Pursuant to the June 20, 2001 Ruling of Administrative Law Judge Mattson, the California Independent System Operator Corporation ("ISO") provides the following comments on USS POSCO Industries' ("USS POSCO") and the California Energy Commission's ("CEC") petitions to modify Decision 01-04-006, both dated June 21, 2001.

COMMENTS

USS POSCO and the CEC make statements in their respective petitions regarding activities the ISO may be required to undertake in order to properly implement the requested modifications. For example, USS POSCO indicates the ISO would, as part of its settlement process, be required to credit only those demand reductions provided pursuant to the Demand Relief Program ("DRP") that are in excess of the customer's OBMC obligations to insure the dual participation issue is properly managed. In similar fashion, the CEC notes that the calculated Real Time Pricing ("RTP") values could be posted publicly on the ISO's website by 4 p.m. each day so participants would have

access to the necessary pricing information.² The ISO files these comments to state its willingness to: (i) publish RTP values provided to the ISO on the ISO's Home Page as necessary to facilitate Real Time Pricing; and (ii) deduct the value of OBMC committed capacity provided by the IOUs from its DRP performance calculations.

CONCLUSION

For the above reasons, the ISO respectfully requests the Commission to consider USS POSCO's and the CEC's petitions with the understanding that the ISO is prepared to undertake the foregoing activities.
