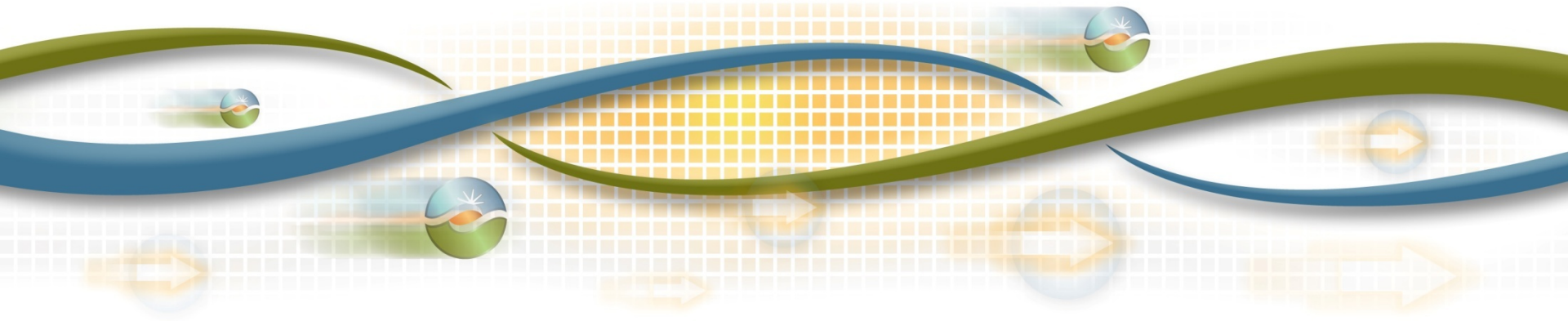

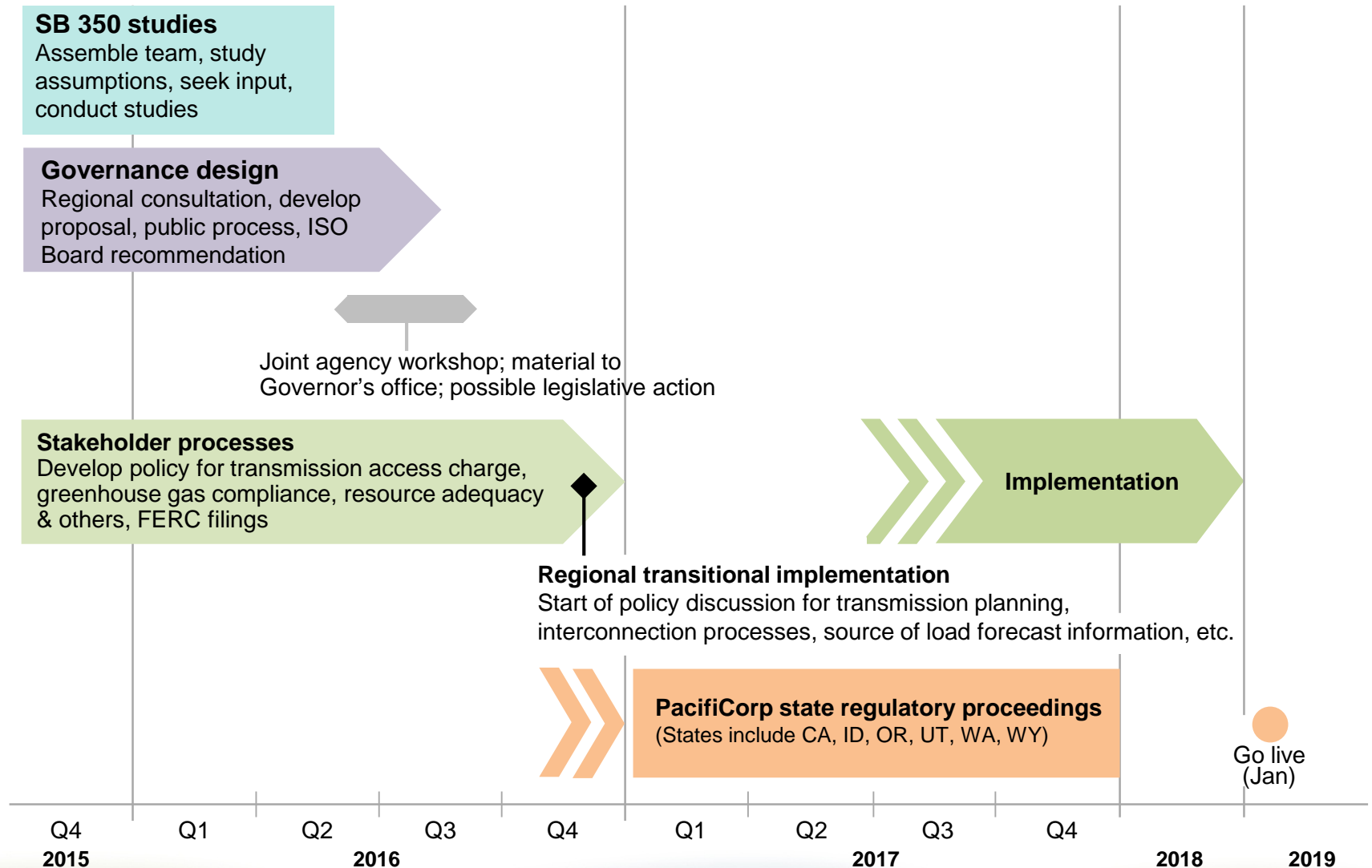

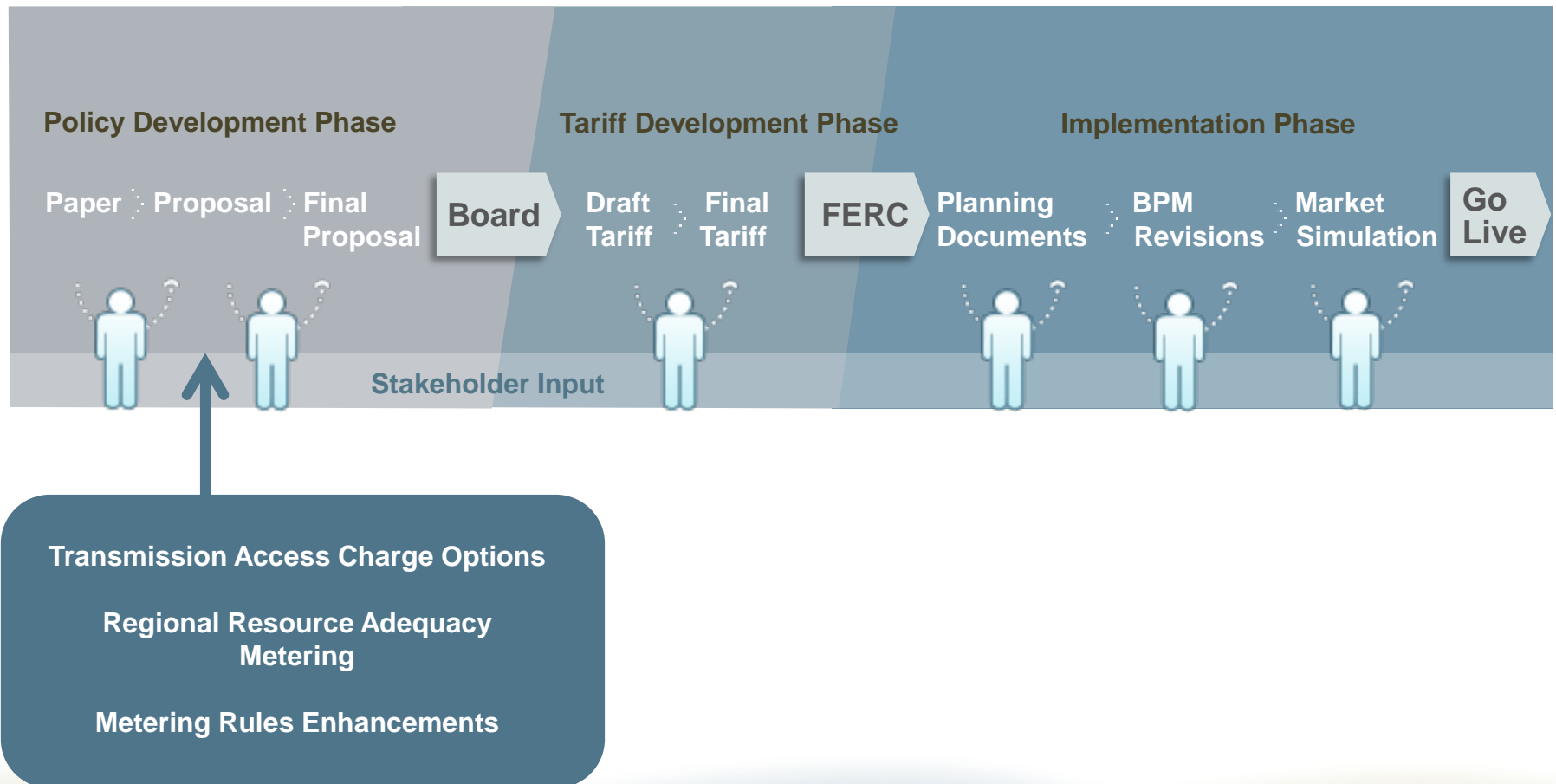
Timeline for regional integration activities

ISO Stakeholder Engagement Process

This diagram represents the typical process, often phases will run in parallel.



Current Stakeholder Initiatives - Regional

Transmission Access Charge Options

This initiative considers whether the existing revenue recovery mechanisms would be appropriate should a transmission owner with a load service territory join the ISO as a participating transmission owner. This initiative began with an issue paper in late October 2015.

Upcoming activities:

- February 10 – The ISO published a straw proposal and accompanying impact assessment tool (with user guide)
- March 1 - (today) Stakeholder meeting on straw proposal (Folsom)
- March 9 - Working group on benefits assessment methodology
- March 23 - Stakeholder comments due on straw proposal AND benefits assessment methodology

Current Stakeholder Initiatives – Regional

Regional Resource Adequacy

This initiative evaluates whether the existing resource adequacy tariff provisions are appropriate for use in a regional ISO balancing authority area that encompasses multiple states. This initiative began with an issue paper in early December 2015.

Upcoming activities:

- February 24 – The ISO published a straw proposal
- March 2 - (tomorrow) Stakeholder meeting on straw proposal (Folsom)
- March 16 - Stakeholder comments due on straw proposal

Note: These dates are tentative until confirmed by a market notice.

Current Stakeholder Initiatives – Regional

Metering Rules Enhancements

This initiative will review existing metering requirements and propose possible revisions to accommodate the growth in renewables, energy storage and distributed energy resources; technology advancements, developer interest in new and complex metering configurations; expansion of regional markets through the energy imbalance market; and, the potential integration of other balancing authority areas into the ISO balancing authority area.

Upcoming activities:

- February 23 – The ISO published an issue paper/straw proposal
- March 3 - Stakeholder call to review the paper/proposal (webconf)
- March 17 - Stakeholder comments due on straw proposal

Upcoming Stakeholder Initiatives (Tentative dates)

Greenhouse Gas Compliance

This initiative will review potential changes to the existing EIM approach for tracking GHG compliance obligations needed to support an expanded ISO balancing authority area that encompasses states outside of California

Upcoming activities:

- Targeted to start in March 2016

Full Network Model Enhancements – Targeted to start in July 2016

SB350 update on upcoming activities

Study Work:

- The ISO held a workshop on February 8th to discuss approach, assumptions, methodology of SB350 studies
 - Comment summary and ISO response are scheduled to be posted on March 18th
- Stakeholder meeting to discuss preliminary results targeted for April 14-15; market notice will be sent when date is confirmed.
