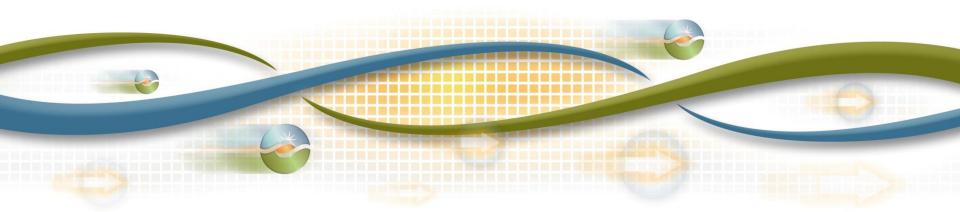




# PacifiCorp Integration Schedule

# Current Stakeholder Initiatives - Regional

## **Transmission Access Charge Options**

This initiative considers whether the existing revenue recovery mechanisms would be appropriate should a transmission owner with a load service territory join the ISO as a participating transmission owner. This initiative began with an issue paper in late October 2015.

- September 28 ISO will publish 2<sup>nd</sup> Revised Straw Proposal
- October 7 ISO will host a stakeholder meeting in Folsom
- October 21 stakeholder comments are due on 2<sup>nd</sup> Revised Straw Proposal

# Current Stakeholder Initiatives - Regional

## Regional Resource Adequacy

This initiative evaluates whether the existing resource adequacy tariff provisions are appropriate for use in a regional ISO balancing authority area that encompasses multiple states. This initiative began with an issue paper in early December 2015.

- September 29 ISO will publish 3<sup>rd</sup> Revised Straw Proposal
- October 6 ISO will host a stakeholder meeting in Folsom
- October 20 stakeholder comments are due on 3<sup>rd</sup> Revised Straw Proposal

# Current Stakeholder Initiatives – Regional

## **Metering Rules Enhancements**

This initiative will review existing metering requirements and propose possible revisions to accommodate the growth in renewables, energy storage and distributed energy resources; technology advancements, developer interest in new and complex metering configurations; expansion of regional markets through the energy imbalance market; and, the potential integration of other balancing authority areas into the ISO balancing authority area.

### **Upcoming activities:**

The schedule has been extended

- September 19 stakeholder comments are due on 2nd supplement to Draft Final Proposal
  - Posted on 9/1/16; web conference held on 9/12/16

# Current Stakeholder Initiatives - Regional

## **Greenhouse Gas Compliance**

This initiative reviews potential changes to the existing EIM approach for tracking GHG compliance obligations needed to support an expanded ISO balancing authority area that encompasses states outside of California. This initiative began in late August 2016.

### **Upcoming activities:**

- September 20 stakeholder comments are due on Issue Paper
  - An Issue Paper was posted 8/29/16 and a conference call was held on 9/6/16
- October 6 ISO will post a Straw Proposal
- October 13 ISO will host a stakeholder meeting at its headquarters in Folsom

## **Study Work:**

SB 350 study work is complete and was submitted to Governor Brown (CA) on September 15, 2016.

Data and information related to the Senate Bill 350 studies are available directly on the Regional Energy Market webpage:

- Responses to stakeholder questions (additional questions about the studies and assumptions) are also available
- Confidential data used in the studies remains subject to confidentiality restrictions; stakeholders are required to execute a <u>non-disclosure agreement</u> with the ISO before accessing confidential data

## SB 350 governance modifications

#### **Governance Work:**

A Revised Proposal for Principles for Governance of a Regional ISO was presented on July 26 at a Joint Agency workshop in Sacramento

### **Upcoming activities:**

- The ISO is revising its proposal on governance principles
  - Both the redline and clean versions will be posted to the CEC docket (16-RGO-01) around the end of September
- The ISO will post a market notice announcing the posting
- The ISO will work with the CEC on a process for accepting comments and holding additional public discussion(s).
