AMENDED NOTICE OF TECHNICAL CONFERENCE

(July 28, 2003)

On July 24, 2003, the Federal Energy Regulatory Commission issued a Notice of Technical Conference regarding Reliability Must-Run (RMR) generation and Must-Offer Minimum Load scheduling in Docket No. ER01-991-000. This amended notice adds Docket Nos. EL03-153-000, EL03-158-000, and EL03-179-000. As stated on July 24, the conference will be held on Tuesday, July 29, 2003 at the Federal Energy Regulatory Commission, 888 First Street, NE, Washington, D.C., beginning at 9:30 a.m. The technical conference will convene in Hearing Room 1.

For reference purposes, we are restating below the background information included in the initial, July 24 Notice of Technical Conference.

In a March 14, 2001 Order in Docket No. ER01-991-000, the Commission directed the California Independent System Operator (CAISO) to make tariff changes to reflect the demise of the PX markets. To date, these changes have not been submitted to the Commission. As a result, the CAISO states that it has been interpreting the existing tariff as requiring RMR unit owners that are pre-dispatched to find bi-lateral counterparties in order to satisfy the Tariff requirement to submit balanced schedules. Certain RMR unit owners have informed us that, when they were unable to find such a counterparty in the past they have submitted a “dummy” load schedule in order to satisfy the balanced schedule requirement. Similarly, certain generators subject to the Must-Offer

requirement state that they are required to schedule their minimum load ahead of real time and have been following the same practice of submitting a “dummy” load in order to balance their schedules.

We have been informed that, following the June 25, 2003 Order to Show Cause Concerning Gaming and/or Anomalous Market Behavior (EL03-137-000, et al.), parties have been reluctant to continue this practice in order to avoid the perception that they are violating the CAISO’s Market Monitoring and Information Protocol. This may result in situations in which parties are unable to schedule energy in the CAISO’s day ahead market because they have no corresponding load. Increased amounts of energy would then be delivered in real time as uninstructed imbalance energy which could cause significant operational problems for the CAISO.

In preparation for this technical conference, parties should be prepared to discuss their views on appropriate solutions to these problems that will be consistent with the parties’ responsibilities under the RMR contracts and Must-Offer obligations.
