ERRATA TO THE COMPLIANCE FILING OF THE CALIFORNIA INDEPENDENT SYSTEM OPERATOR CORPORATION IN RESPONSE TO COMMENTS

The California Independent System Operator Corporation ("CAISO") submits this Errata to the CAISO's March 22, 2006 conformed Simplified and Reorganized Tariff ("S&R Tariff").

In response to the CAISO's initial September 22, 2005 S&R Tariff filing, intervenors expressed concern with the manner in which the CAISO integrated former Schedules and Bids Protocol ("SBP") Section 7.5 into S&R Tariff Section 6.6. In its November 4, 2005 Answer, the CAISO addressed this concern by proposing to delete the provisions of former SBP 7.5 and replace them in S&R Tariff Section 6.6 with the provisions of the then-conformed S&R Tariff Section 6.4. The CAISO filed proposed revisions to this effect on January 13, 2006, and the Commission accepted those revisions in its order of February 24, 2006. However, when the CAISO undertook to file a "conformed" version of the S&R Tariff on March 22, 2006 to incorporate the revisions previously accepted by the Commission, "ISO Protocols" was erroneously changed in Section 6.6 to "Business Practice Manuals". Accordingly, Attachment A to this Errata filing contains both a blacklined and clean S&R Tariff Section 6.6 to reflect

6.6 Failure or Corruption of the WEnet.

The ISO shall, in consultation with Scheduling Coordinators, make provision for procedures to be implemented in the event of a total or partial failure of WEnet or the material corruption of data on WEnet and include these procedures in the Business Practice Manuals ISO Protocols. The ISO shall ensure that such alternative communications systems are tested periodically.

ATTACHMENT A.2 CLEAN CONFORMED S&R TARIFF SECTION 6.6

Effective: March 1, 2006

- 6.5 Information to be Provided By Connected Entities to the ISO.
- **6.5.1** Each Participating TO and Connected Entity shall provide to the ISO:
- A single and an alternative telephone number and a single and an alternative facsimile number by which the ISO may contact 24 hours a day a representative of the Participating TO or Connected Entity in, or in relation to, a System Emergency;
- 6.5.1.2 The names or titles of the Participating TO's or Connected Entity's representatives who may be contacted at such telephone and facsimile numbers.
- 6.5.2 Each representative specified pursuant to Section 6.5.1 shall be a person having appropriate experience, qualification, authority, responsibility and accountability within the Participating
 TO or the Connected Entity to act as the primary contact for the ISO in the event of a System Emergency.
- 6.5.3 The details required under this Section 6.5 shall at all times be maintained up to date and the Participating TO and the Connected Entity shall notify the ISO of any changes promptly and as far in advance as possible.

6.6 Failure or Corruption of the WEnet.

The ISO shall, in consultation with Scheduling Coordinators, make provision for procedures to be implemented in the event of a total or partial failure of WEnet or the material corruption of data on WEnet and include these procedures in the ISO Protocols. The ISO shall ensure that such alternative communications systems are tested periodically.

6.7 Confidentiality.

All information posted on WEnet shall be subject to the confidentiality obligations contained in Section 20 of this ISO Tariff.

6.8 Standards of Conduct.

The ISO and all Market Participants shall comply with their obligations, to the extent applicable, under the standards of conduct set out in 18 C.F.R. §37.
